Background

What is FAIR Ottawa?

The Foundation Against Intolerance and Racism (FAIR) is a nonpartisan, nonprofit organisation with over one hundred chapters and more than thirty-five thousand members across Canada and the United States. More details can be found on the organisation's website www.fairforall.org.

FAIR is dedicated to advancing civil rights and fundamental freedoms for all Canadians, and promoting a common culture based on fairness, understanding, and humanity. Recognizing Canada as a beautiful mosaic of diverse cultures and people, FAIR supports pro-human beliefs that appreciate the unique identities and common humanity of every single person, regardless of their viewpoints or immutable traits such as skin colour, ancestry or ethnicity.

The FAIR Ottawa chapter was formed in April 2022 and meets twice a month. Its activities are focused on promoting critical thinking, free inquiry, open debate and a common culture based on fairness, understanding, and humanity in Ottawa's schools, workplaces and municipal government.

Why we did the survey

The purpose of the survey is to solicit the views of candidates running for election as trustees of the Ottawa Catholic School Board on questions that are important to FAIR members. Through reporting each candidate's views, FAIR Ottawa aims to help voters decide who to support in the October 24th election. FAIR does not endorse or support any candidate for political office.

How we conducted the survey

Creating the survey

At the first FAIR Ottawa meeting in August of this year a set of guiding questions was determined by the membership. These questions were then refined by a smaller working group, incorporating feedback from members and creating the final survey which is displayed in appendix one at the end of this document. The survey was hosted on a section of the FAIR website where candidates were invited to fill out the survey and submit their responses.

Contacting candidates

Candidates were contacted using the information from the City of Ottawa's website of *Certified and acclaimed candidates and registered third party advertisers* (link). Candidates were invited to complete the survey by email on Wednesday August 31st, 2022. All but six candidates had an email address listed. Two weeks after sending the first email, all those who had yet to provide a response were contacted by telephone. Thirteen phone calls were made in total. If candidates picked up the call they were reminded of the email and asked to fill out the survey. If they did not pick-up, a message was left with the same information.

How results are being presented

The information gathered from the candidates is being presented exactly as it was submitted through the surveying tool. The results below display all the information that was collected. FAIR Ottawa did not change or edit the responses in any way. The aim in presenting the responses this way is to accurately and faithfully represent what the candidates submitted.

In order to ensure the survey responses are useful to voters they are organised by school board zone. Included are the names of primary and secondary schools within the zone as they are displayed on the school board's website. There is a list of candidates, in alphabetical order for that zone, along with information on whether or not the candidate responded to the survey. After the list of candidates for a zone is each of the questions in the survey and the responses candidates provided. If the candidate left a response field blank, the results don't show anything for that question.

As a parent of two kindergarteners, I was very unhappy with the Board's approach to COVID, especially as it pertained to mandates and policies. The Board's process (lack thereof) was one of rule by decree, with little input from even the Board of Trustees. Decisions were made last-minute, and not in line with Public Health guidelines.

I am also very concerned about the Board's continued push for D-I-E processes to be embedded throughout its policies, that will ultimately affect students. Anti-racism is not the opposite of racism. The negative consequences of these policies far outbalance any good that may come from them, in my opinion.

Cameron Bonesso

Hello, my name is Cameron Bonesso and I'm running to be your next Ottawa Catholic School Board Trustee (OCSB) for Zone 10 (Wards 12, 13 and 14).

For years, I've had the pleasure and privilege to live in Zone 10 here in Sandy Hill. Currently, I'm a 22-year-old university student at the University of Ottawa studying Political Science and Public Administration. I also work full-time as the President of Constituent Manager Solutions which is a consulting firm that I founded back in 2020 with my business partner, Gyasi Swann. Before starting my own firm, I worked for three years at the House of Commons as an Executive Assistant and later as Special Advisor to a Member of Parliament.

You may be wondering why exactly is someone as young as myself running for school board trustee — and that's a great question.

One thing I consistently notice about municipal politics is that parents don't often pay attention to the work of our community's local school boards despite them having a large impact on their children's education. I want to work to change that. As a young adult, I can bring a fresh voice to our city's Catholic school board and inspire more members of our community to get involved. Coming out of the COVID-19 pandemic, it's clear that many students have faced disruptions and difficulties with their own learning experience. As a university student, I know first-hand how the pandemic has impacted the mental health of young people

which is why my top priority as a candidate is advocating for increased funding for board-wide mental health programs for not only students, but staff as well.
